

## Sensorion announces that a General Meeting of shareholders will be held behind closed doors on May 18, 2021 alongside the publication of its 2020 annual financial report

**Montpellier, April 9, 2021 – Sensorion (FR0012596468 – ALSEN)** a pioneering clinical-stage biotechnology company which specializes in the development of novel therapies to restore, treat and prevent within the field of hearing loss disorders, announces that the company's Board of Directors has approved the procedure for holding a Combined General Meeting behind closed doors (*à huis clos*) on Tuesday, May 18, 2021. Additionally, the company announces that its annual financial report for the year ending December 31, 2020, is available to the public and filed with the French financial market authority (AMF).

In accordance with article 4 of ordinance n° 2020-321 of March 25, 2020 as amended by ordinance n° 2020-1497 of December 2, 2020 and whose period of application was extended by Decree No. 2021-255 of March 9, 2021 adapting the rules for meetings and deliberations of general meetings and governing bodies of legal entities and entities without legal personality under private law due to the Covid-19 epidemic, the Board of Directors decided to hold the Combined General Meeting of May 18, 2021 behind closed doors, without the shareholders, and other persons entitled to attend, being present, either physically or by telephone or audiovisual conference.

The notice of meeting of the General Meeting was published on April 9, 2021 in the *Bulletin des Annonces Légales Obligatoires* (BALO) number 43 (announcement 2100834).

Shareholders are invited to consult the convening notice of this General Meeting which will be published in the BALO (*Bulletin des annonces légales obligatoires*) and in a newspaper empowered to publish legal notices in due time.

These notices, as well as all the preliminary documents regarding the general assembly, will be available for consultation in due time on the company's website <https://www.sensorion.com>.

### Terms and conditions of participation to the General Meeting

Only shareholders having registered their shares at least two business days prior to the date of the general meeting, i.e. midnight, Paris time, on May 14, 2021, will be able to participate in the general meeting.

For shareholders holding bearer shares (*au porteur*), their authorized intermediary must provide them with a certificate of shareholding (*attestation de participation*).

Given that shareholders are not entitled to attend the meeting in person, they may vote by mail or give their proxy to the Chairman using the form provided for this purpose, which will be available for download from the company's website <https://www.sensorion.com> or requested by email at [contact@sensorion-pharma.com](mailto:contact@sensorion-pharma.com).

In accordance with Article 3 of Decree no. 2020-418 of April 10, 2020 as extended and amended by Decree no. 2020-1614 of December 18, 2020, proxies and voting instructions may be sent by email to [contact@sensorion-pharma.com](mailto:contact@sensorion-pharma.com).

In accordance with Article 6 of Decree no. 2020-418 of April 10, 2020, as extended and amended by Decree no. 2020-1614 of December 18, 2020, in the event that a shareholder grants a mandate to a named person<sup>1</sup>:

- the mandates stating the identity of the proxies must reach the Company by or on the fourth day prior to the date of the General Meeting, i.e. until May 14, 2021;

<sup>1</sup> If a shareholder wishes to give a proxy to a named person, he or she should contact the Company. It is specified that proxies, like shareholders, may not physically attend the meeting.

- the proxy holder sends his instructions, for the exercise of the mandates he holds, to the Company no later than the fourth day prior to the date of the General Meeting at the latest, i.e. May 14, 2021 at the latest.

In accordance with Article 7 of Decree no. 2020-418 of April 10, 2020, as amended by Decree no. 2020-1614 of December 18, 2020, a shareholder who has already cast a postal vote, sent a proxy or requested an admission card or a certificate of participation may choose another means of participation in the general meeting, provided that their instructions to this effect are received within a period of time compatible with the rules relating to each means of participation recalled above.

Previous instructions received are then revoked.

There are no plans to vote or to participate by electronic means of telecommunication for this meeting and, consequently, no site referred to in Article R.225-61 of the French Commercial Code will be set up for this purpose.

## **Written Questions**

In accordance with Article 8-2 of Decree no. 2020-418 of April 10, 2020, as amended by Decree no. 2020-1614 of December 18, 2020, shareholders may submit written questions to the Board of Directors until the second business day prior to the date of the Shareholders' Meeting, i.e. midnight, Paris time, on May 14, 2021. Such written questions should be sent, preferably by email, to [contact@sensorion-pharma.com](mailto:contact@sensorion-pharma.com).

They must be accompanied by a certificate of registration of the shareholder's shares.

In accordance with Article 8-1 of Decree no. 2020-418 of April 10, 2020, as extended and amended by Decree no. 2020-1614 of December 18, 2020, the Board of Directors decided, at its meeting of March 17 2021, to appoint INVUS PUBLIC EQUITIES and SOFINNOVA PARTNERS as scrutineers.

Sensorion has launched three gene therapy programs, currently at preclinical stage, aimed at correcting hereditary monogenic forms of deafness including deafness caused by a mutation of the gene encoding for Otoferlin, hearing loss related to gene target GJB2 as well as Usher Syndrome Type 1 to potentially address important hearing loss segments in adults and children. The Company is potentially uniquely placed, through its platforms and pipeline of potential therapeutics, to make a lasting positive impact on hundreds of thousands of people with inner ear related disorders, a significant global unmet medical need.
